***\*\*ALL riders under the age of 18 must wear an SEI or SEI/ASTM approved helmet in all classes and warm-up areas.***

*Additional rules & information:*

1. All participants must be at least 8 years of age on or before September 1, 2009.
2. **Walk Jog may not cross enter into any WTL classes (except schooling)**
3. Stallions are prohibited on showgrounds.
4. Classes may be combined if there are less than 3 entries in either class.
5. Anyone placing first or second in classes 2 or 3 will be eligible to compete in the Grand & Reserve Halter class. Please don't leave the entry gate area.
6. Jr./ Interm. 4-H = ages 8-13 ; Sr. 4-H = ages 14-18. Must be current member of 4-H club.
7. Schooling of horses by people other than the exhibitor IS allowed.

***\* Showing uncastrated males past Dec. 31 of the year of his birth is prohibited. Wet (nursing) mares are prohibited\****

If you have any questions about the requirements or procedures for any class, please refer to the Florida State 4-H Horse Show Official Rule Book. The official rule book for this show is the "Florida 4-H Area and State Horse Shows Official Rules 2008." The only exceptions to this rule book are as follows:

- \*\* Warming up by persons other than the exhibitor WILL be allowed.
- \*\* Training aids will be allowed only in schooling classes. Please check the rule book for approved equipment for all other classes.
- \*\* Stallions are NOT permitted on the show grounds. *4-H Rule: Showing uncastrated males past December 31 of the year of his birth is prohibited.*

Exhibitors will be disqualified from a class if there is coaching from the sidelines.

For JR and SR classes, the contestant's age is as of September 1, 2009 and they must be registered 4-H members. Each contestant should enter the proper class according to age of contestant.

The show will be held on the dates scheduled barring a natural catastrophe. It is the responsibility of the exhibitor's parents or guardians to determine if they are able to compete safely. In case of inclement weather, all contestants should realize that the conditions and facilities are the best available as determined by the show management and must accept these conditions and show accordingly.

You must have in your possession, a copy of your current Coggins upon entering the Horse Show facilities.

Scratches and additions to classes must be done at least 2 classes prior to the class in which you will be scratching or adding. **No refunds will be given for scratches done after this time limit.**

**\*\*Either an open check or payment in full will be due at registration in order to receive your exhibitor number.\*\***

4-H Members: You must enter one showmanship class. **(\$6 for 4-H members, \$8 for non members)**
