## PROCEDURE

1. Type or print information requested on reverse side.
2. Attach two (2) photographs (approximately 3 ½ X 3 ½ inches), one of each side of the horse being registered.
3. Get verification and signature of the 4-H Club Leader.
4. The leader or member must return the forms back to the 4-H Extension Agent no later than **DECEMBER 31, 2008**.
5. The 4-H Agent will issue project certification to the member.

## REQUIREMENTS

1. Must be an active and current 4-H Club member, meeting all the membership requirements established by the club and county program.
2. Manage at least one horse of any age or breed as a 4-H horsemanship project. The horse must be owned or leased by the 4-H member, his parents, brother, sister, or legal guardian, and certified as a 4-H project by **DECEMBER 31, 2008**.
3. For competitive 4-H events, members must have had the horse or pony prior to competition. Certification form issued by the Extension Agent must be shown to enter a competitive event.
4. Counties may allow for replacement of a project horse or pony prior to the Area E Show if the project horse or pony is certified unsound by a veterinarian and approved by the County Extension Agent and 4-H Horse Club Leader.
5. The 4-H member must keep and submit to the County Agent a 4-H HSR02 Record Form on the Project Horse. Agents are advised that it is their responsibility to certify that a member has met the requirements to compete at the area level.
6. Leasing will be permitted with approval of the County Agent and/or Advisory Committee. A certified lease for 4-H 514 **MUST** be on file at the County Extension Office by **December 31, 2008** for the horse to be eligible to participate in the Area or State show or county 4-H horse events in the Florida 4-H Horse Program.
